Technical requirements for reports

- ✓ The materials must be of not less than 3 and not more than 5 filled pages, typed in MS Word;
- ✓ Article must be accompanied by an abstract and keywords in three languages (Kazakh / Russian and English);
- ✓ Pictures executed in jpg or gif;
- ✓ Page margins: left, right, top and bottom - 2 cm;
- ✓ Font: Times New Roman, size 12;
- ✓ Spacing - single;
- ✓ The indentation at the beginning of the paragraph - 1.25 cm;
- ✓ The pages are not numbered;
- ✓ The number of authors of the report should not exceed three;
- ✓ The next line in the center theme of the report in bold capital letters;
- ✓ A row below the name of the author (authors);
- ✓ A row below the name of the university, institutions and cities, e-mail;
- ✓ After the interval starting with an indent is keywords (up to 5);
- ✓ After the interval starting with an indent is summary in two languages (3-5 lines);
- ✓ After the interval starting with an indent is article;
- ✓ At the end of the article is a list of references.

Materials are sent to the email address of the organizing committee with the file name and the name of the participant.
